<b>31 OCTOBER 2016</b>	<b>NATIONAL CLOSING DATE</b> for all Common Application Forms to be received by the School Admissions Team at Local Authority (LA). Applications received by 31 October are 1 <sup>st</sup> round applications.
<b>18 November 2016 (WCC)</b>	LA forwards list of applications where parents have nominated a school outside of the LA area to Admissions Authority - Excalibur Academies Trust (EAT).
<b>24 November 2016 (BCC) 26 November 2016 (WCC)</b>	LA forwards 1 <sup>st</sup> round application list to Admission Authority (Excalibur Academies Trust (EAT) for admission to St John's and Fairfield High School.
<b>16 December 2016 (WCC)</b>	Deadline for any exceptional circumstances applications to be received by LA.
<b>9 January 2017 (WCC)</b>	Final 1 <sup>st</sup> round application list sent by LA to Admission Authority (Excalibur Academies Trust (EAT) for admission to St John's.
<b>9 January 2017 (BCC) 16 January 2017 (WCC)</b>	EAT's Admission Authority returns ranked list of 1 <sup>st</sup> round applications to the LA.
<b>24 February 2017 (BCC) 27 February 2017 (WCC)</b>	List of successful offers of places to St John's & Fairfield HS sent to EAT.
<b>1 MARCH 2017</b>	<b>NATIONAL OFFER DATE</b> - Notification of 1 <sup>st</sup> round offers despatched to parents from LA.
<b>9 March 2017 (WCC)</b>	Deadline for receipt by LA of 2 <sup>nd</sup> round applications (received between 1 November 2016 – 9 March 2017)
<b>15 March 2017</b>	Last date for 1 <sup>st</sup> round offers to be accepted by parents. (If an offer has not been accepted by this date it will be assumed the place is not wanted and will be offered to another applicant.)
<b>23 March 2017 (WCC)</b>	LA forwards 2 <sup>nd</sup> round application list for admission to St John's.
<b>6 April 2017 (WCC)</b>	EAT to return ranked list of 2 <sup>nd</sup> round applications for St Johns.
<b>28 April 2017 (WCC)</b>	Notification of 2 <sup>nd</sup> round offers despatched to parents from LA.
<b>12 May 2017 (WCC)</b>	Last date for 2 <sup>nd</sup> round offers to be accepted by parents (If an offer has not been accepted by this date it will be assumed the place is not wanted and will be offered to another applicant.)
<b>15 May 2017 (WCC)</b>	3 <sup>rd</sup> round applications (received after 9 March 2017) can be considered from this date (in date order)
<b>June 2017</b>	Appeals heard.
<b>22 July 2017</b>	Applications received after this date will be passed to EAT for consideration as an in-year application.
<b>31 August 2017</b>	Final list of all expected starters sent to EAT.
