



Admissions 2019/2020 – Appeal Hearings – Marlborough Hub

Applicants, who have had their application to an Excalibur Academy refused, have the right to submit an appeal to an Independent Appeal Panel and/or request to be placed on a waiting list.

Please note that applications to appeal must be received by 29 March 2019 when they are part of the normal admissions round for September 2019 for secondary places and by 17 May 2019 for primary places and within 20 school days from the date of the offer or refusal letter, at all other times.

Normal Admissions Round Appeals will be held on **Tuesday 11 June and Wednesday 12 June 2019**. Appellants will receive 10 school days' notice of their individual hearing. Results of all appeals will be confirmed to appellants no more than two weeks after the hearing date.

Hearings for Appeals lodged outside of the Normal Admissions Round will be heard within 30 school days of the appeal being lodged.

Appeals are heard in June/July. Appeals lodged in late June or in July will not be heard until mid/late September.
